I acknowledge and agree that:

1. My Negotiated Fee is to be calculated on the closing market value of all my account's settled assets for each calendar day, collected by ADSC monthly, and remitted to my Dealer.
2. Collection of the advisor fee is the responsibility of ADSC and is paid to the dealer on a monthly basis. Any adjustment required to a fee calculation will be processed and included in the next monthly cycle.
3. The account is subject to the ADSC Annual Trustee fee and all applicable fees and interest rates as per the current ADSC fee schedule in effect.
4. ADSC may, from time to time, amend the terms of the addendum by providing me with at least 60 days written notice.
5. This Application continues to apply until ADSC receives written notification from me.
6. This Negotiated Fee will be carried over from RSP plan to a RIF plan, on automatic rollover due to age (71). If the RSP rollover to a RIF is voluntary (initiated by me as a transfer), I must provide new agreement for the new RIF plan.
7. This Application continues to apply after my death until written Estate settlement instructions are received by ADSC from my Estate executor or my designated beneficiary.
8. Fees are subject to applicable tax.
9. I hereby request and authorize Agora Dealer Services Corp. ("ADSC") as administrator of the above mentioned plan, to accept my instructions to withdraw from the mutual fund listed above. Proceeds of the withdrawal will be distributed to my advisor as payment for a management fee as outlined in the Fee For Service Application.
10. I hereby authorize Agora Dealer Services Corp. ("ADSC") as administrator of the above mentioned plan, to use the Default hierarchy option if the mutual fund listed above is depleted and/or the EFT payment has been rejected by my Bank, until ADSC receives written notification from me.
